Boil Advisory vs Boil Order

Understanding water quality warnings

Due to new regulations implemented by DNR in 2016, WRWA was required to issue multiple notices throughout the year. As these regulations continue to change, WRWA will continue to comply with DNR requirements.

A **boil advisory** is a precautionary measure issued by the water utility to alert customers when there is a potential for compromised water quality. It is *recommended* that customers boil all water used in the preparation of food and beverage for consumption for 1 minute before using.

A **boil order** is issued by the DNR to the water utility system when there is a confirmation that contamination is present in the water system. It is *essential* that customers boil all water used in the preparation of food and beverage for consumption for 1 minute before using.

If it is necessary to issue a boil advisory or boil order a notice will be posted on our website

www.wapelloruralwater.com, as well as local radio and TV stations. Once lifted an official notice will be provided to the same outlets.

News from the Construction Crew

The construction crew has installed 41 new water services as well as routine maintenance of our water system. If you suspect a leak or have any concerns, please contact our office.

As part of a county paving project, construction on Rock Bluff Road began this summer. We relocated five services and approximately one mile of water main. The project went smoothly.

We completed routine maintenance on our Kirkville & Bidwell Water Towers. The users near these towers may have experienced decreased water pressure during the renovation period. Thank you for being patient with us.

We've been working with Dakota Access Pipeline to ensure that pipeline construction doesn't interfere with our water lines. We identified 26 crossings, and had no service interruptions during construction.

If you stop by our office building on Shaul Ave. in Ottumwa, you'll notice a few changes. We began our building renovation in November, and hope to have it completed very soon.
